2. Then email the form to WITSA Chairman Santiago Gutierrez (sgutierrez@witsa.org) or I (jpoisant@witsa.org) by FRIDAY, September 30th before 1:30pm Brasilia time (12:30pm EDT)

Dear Colleagues,

As you know on Sunday, October 2nd in Brasilia, WITSA will conduct the elections for its Board of Directors and Chairman for the 2016-2018 term, and vote on other important matters (see agenda posted at <http://witsa.org/witsa-wp-site/witsa-ga-bod-related-meetings-october-1-2-2016-brasilia-brazil/>). In order to fulfill WITSA's quorum requirements, we kindly request your support by casting your association's votes in one of the following three (3) different ways:

1. The first is by your association having its representative **physically present** and voting at the General Assembly meeting (*if you have not yet RSVP'ed, please do so asap.*).
2. The second is for you to assign your vote **by PROXY** (see attached proxy form) to the Chairman or another WITSA member that will be present at the meeting (Bylaws Section 8.1; ref. http://witsa.org/witsa-wp-site/wp-content/uploads/2013/10/WITSA_Bylaws_Aug2011.pdf). No proxy holder may hold more than 2 proxies and WITSA Chairman Santiago Gutierrez (sgutierrez@witsa.org) or I (jpoisant@witsa.org) must receive proxy forms by FRIDAY, September 30th before 1:30pm Brasilia time (12:30pm EDT). **PROXIES WILL NOT BE ACCEPTED AFTER THIS TIME.** Please also note that proxy votes are only permitted at the General Assembly meeting (ref. Decision Block #2 below), not at the Board of Directors meetings.
3. The third option to vote is for your association's representative to **call-in**, as explained below.

For those of you planning on the third option (remote participation) it is required that you notify me by email (at jpoisant@witsa.org) no later than Friday, September 30th by midnight Eastern Daylight Time) of your intention to vote via our conference call. Please also include a direct-line number, in case we get disconnected and I need to call you back.

In order to vote, please use the computer link provided at the end of this message (these will be open for the entire duration of the General Assembly and Board meetings on October 2nd). You may also call me directly on my cell-phone at +1 703 728-4547 (if you are unable to reach me by phone, you may also contact Anders Halvorsen directly at + 1 571 265-5964). In order to vote, please be sure to connect or call during the two decision-block times, as indicated below.

NOTE: In order to optimize the call experience, we have developed the following guidelines for your kind attention:

- ? Connect digitally (not by phone), if possible: The best experience is where all participants use a digital connection, that is, a USB headset, connected to a computer. If a USB headset is not available, then a headset that connects via a 3.5mm audio plug but bear in mind, this is an analogue connection and may be subject to some interference.
- ? Connection using a mobile device, such as an iPhone/iPad or Android phone/tablet, and the GoToMeeting app, with an earpiece also works very well. NB: wireless Blue Tooth earpieces can sometimes add a delay to the call.
- ? If connection is via a computer, using the computer's speakers and a separate microphone, or a phone/tablet without earpiece, it is critical that participants mute their microphones at all times except when speaking. It is also important that participants using just a laptop or PC without headset do not use their keyboard for typing during the call, as their keyboard activity affects all participants
- ? Participants should try to locate themselves in a relatively quiet environment for the duration of the call, if possible.
